Report of the Advisory Committee on Administrative and Budgetary Questions

Addendum

Fifth report: utilization of the development dividend

1. The Advisory Committee on Administrative and Budgetary Questions has considered the report of the Secretary-General on utilization of the development dividend following the establishment of the Development Account (A/53/374). During the Committee's consideration of the report, representatives of the Secretary-General provided additional information.

2. In paragraph 6 of its resolution 52/235 of 26 June 1998, entitled "Development Account", the General Assembly requested the Secretary-General to submit proposals on the use of the funds available under a new section 34 of the programme budget for the biennium 1998–1999. Upon enquiry, the Advisory Committee was informed that the proposals were being presented to the Second Committee in October 1998.

3. The Advisory Committee notes that the report is part of a first attempt to start a process of implementation of the Development Account. When the Account is fully operational, project proposals should be reviewed in the context of the proposed programme budget.

4. As indicated in paragraph 6 of the report, the projects proposed for funding by the Development Account have been developed on the basis of the performance criteria indicated

in the report of the Secretary-General on the Development Account (A/53/7/Add.1), in which it indicated that it would take up the annexes in document A/52/1009 in the context of its consideration of document A/53/374.

5. With regard to the information contained in annex I of document A/52/1009, the Advisory Committee notes that it deals with the types of efficiency measures to be implemented throughout the Secretariat. In this connection, the Committee recalls its related comments in its first report on the proposed programme budget for 1998–1999. In connection with the information contained in annex II of document A/52/1009 on areas where the resources from the Development Account could be utilized, it is the view of the Committee that this information has been superseded by the proposals contained in document A/53/374.

6. The Advisory Committee notes from paragraph 3 of document A/53/374 that the proposals draw upon and contribute to the relevant priorities and subprogrammes established in the medium-term plan for the period 1998–2001. However, the proposed projects would complement and not substitute for existing activities. In this connection, the Committee recalls paragraph 21 (a) of document A/52/1009, in which the Secretary-General

indicated that one of the principles to guide project formulation is that the projects should complement, and not substitute for, existing programme activities. The Committee expects that future submissions of the Secretary-General should contain sufficient and specific information to confirm that projects are regional and/or interregional in nature and that they are not substitutes but complementary. Furthermore, the Committee is of the view that resources budgeted under section 34 should be available to fund new projects rather than existing mandated activities. Once submitted by the Secretary-General and approved by the General Assembly, these new projects would become mandated activities.

7. In this connection, the term “complement” needs to be precisely defined as to whether it applies to activities funded from the regular budget only or whether it also covers extrabudgetary activities. The Advisory Committee points out that the use of the Development Account to fund extrabudgetary activities would involve the transfer of resources from the regular budget to extrabudgetary activities. The Mercure satellite earth stations project (A/53/374, paras. 31–37), for example, is an extrabudgetary activity, which if funded from the Development Account would amount to using resources from the regular budget to fund extrabudgetary activities. The General Assembly may therefore wish to consider that the term “complement” should not apply to extrabudgetary funded programmes. The Committee points out that to the extent that any of the projects outlined in document A/53/374 deviate from the principles outlined above, they should not be considered a precedent.

8. As indicated in paragraph 2 above, the Secretary-General was requested by the General Assembly to submit proposals on the use of funds available under section 34 of the programme budget for the biennium 1998–1999. The Advisory Committee observes that unlike section 21 of the programme budget, which is demand-driven in the sense that it deals with direct requests from individual Member States, section 34 is much more at the initiative of the United Nations, since the United Nations is, of necessity, involved in the planning and programming of regional and/or global activities.

9. The Advisory Committee recalls that for the biennium 1998–1999, the General Assembly, in its resolution 52/221 A of 22 December 1997, had appropriated an amount of \$13,065,000 for the Development Account under section 34 of the programme budget. The Committee notes from the annex in document A/53/374 that the total resource requirements for the projects amount to \$12,305,000, leaving a balance of \$760,000. Upon request, a breakdown of the costs by project was provided to the Committee and is attached to the present report as an annex. However, the

information was not analysed by the Committee. In the opinion of the Committee, irrespective of the balance of \$760,000, it is unlikely that the total amount of \$13,065,000 will be programmed and fully utilized during the biennium. In this case, the procedure for carry-over will be applied and the proposed programme budget for 2000–2001 should include proposals for the full use of resources under the account, including any balance carried over.

10. The Advisory Committee notes from document A/53/374 that each proposed project sets forth relevant indicators to measure whether and to what extent the expected results are to be achieved. The Committee welcomes the attempt to provide indicators. However, it is the view of the Committee that there is a need for further refinement and precision in the delineation of indicators, including a description of the situation before the implementation of the projects so as to be able to better measure the results achieved.

11. Upon enquiry, the Advisory Committee was informed that the resource requirements of the proposed projects did not involve staff costs, nor has the question been addressed of how ongoing maintenance costs for projects will be funded. The Committee expects that future reporting will contain fully costed project proposals.

Proposal A: Promotion of electronic commerce (United Nations Conference on Trade and Development)

Preparation of policy-oriented studies on issues related to a global framework for electronic commerce and the effects of internationally agreed commitments and/or standards. Includes (a) \$120,000 for 12 work-months of consultancy (at \$10,000 per month) for policy-oriented analyses, designed for government officials, on two groups of issues: the impact of current proposals made in the Organisation for Economic Cooperation and Development, the World Trade Organization and elsewhere for a global framework for electronic commerce; and the nature and implications of potential internationally agreed commitments/standards in the area of trade facilitation and electronic commerce on government policies in the various sectors involved, and (b) \$120,000 for 12 months of consultancy (at \$10,000 per month) for analyses of the effects of international documentary standards and business practices for electronic commerce (at both the government and industry levels) on businesses in developing countries and countries in transition (in support of activities (a) and (b) under para. 23).	240,000
